

Personal Management Agreement

AGREEMENT made this ____ day of _____, 20____, by and between _____ ("Artist") and _____ and _____ (jointly and severally referred to herein as "Manager").

WITNESSETH:

WHEREAS, Artist wishes to obtain advice, guidance, counsel and direction in the development and furtherance of Artist's career, both individually and in Artist's capacity as a member of any group of which Artist is now or hereafter becomes a member or with which Artist is otherwise associated, as a musician, composer, arranger, publisher, recording artist, producer, actor, writer and/or performing artist, as well as any and all uses of Artist's name, likeness, photograph and voice for any and all forms of trade, commerce, advertising, endorsements, merchandising and other such forms of exploitation, and in such new and different areas within which Artist's artistic talents can be developed and exploited, whether now known or hereafter devised, including, without limitation, in any and all "media," which is defined as any means of conveying information, whether now known or hereafter devised, including, but not limited to, the internet, digital files, downloadable files, compact disc ("CD"), digital video disc ("DVD"), minidisc or other portable media, television, film, broadband, and/or radio; and,

WHEREAS, Manager wishes to render such advice, guidance, counsel and direction to Artist;

NOW, THEREFORE, in consideration of the mutual promises herein contained, it is agreed as follows:

1. Artist, both individually and in Artist's capacity as a member of any present and/or future musical or other group, engages Manager and Manager agrees to render services as a personal manager to provide advice, guidance, counsel, and direction to Artist as Artist may reasonably require to further Artist's career as a musician, composer, arranger, publisher, recording artist, producer, actor, writer and/or performing artist, as well as with respect to any and all uses of Artist's name, likeness, photograph and voice for any and all forms of trade, commerce, advertising, endorsements, merchandising and other such forms of exploitation, and in such new and different areas within which Artist's artistic talents can be developed and exploited, whether now known or hereafter devised, including, without limitation, in any and all "media," which is defined as any means of conveying information, whether now known or hereafter devised, including, but not limited to, the internet, digital files, downloadable files, compact disc ("CD"), digital video disc ("DVD"), minidisc or other portable media, television, film, broadband, and/or radio. Manager duties shall include the following services:

(a) To supervise and direct Artist's professional activities and, on Artist's behalf, to consult with others so as to assure the proper use and marketing of Artist's services; and

(b) To be available at reasonable times and places to confer with Artist in connection with all matters concerning Artist's professional career, interests, services and publicity; and

(c) To provide advice and counsel regarding the exploitation of Artist's personality in all media, as defined in paragraph one (1), and in connection therewith, to approve and permit, for the purpose of trade, advertising and publicity, the use, dissemination, reproduction and publication of Artist's name, photographic likeness, voice and artistic and musical materials; and

(d) To represent Artist in all dealings with any union; and
