

## Personal Management Agreement

AGREEMENT made this \_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between \_\_\_\_\_ ("Artist") and \_\_\_\_\_ and \_\_\_\_\_ (jointly and severally referred to herein as "Manager").

### WITNESSETH:

**WHEREAS**, Artist wishes to obtain advice, guidance, counsel and direction in the development and furtherance of Artist's career as a [choose one only: musician, composer, arranger, publisher, recording artist, producer, actor, writer and/or performing artist]; and,

**WHEREAS**, Manager wishes to render such advice, guidance, counsel and direction to Artist;

**NOW, THEREFORE**, in consideration of the mutual promises herein contained, it is agreed as follows:

1. Artist engages Manager and Manager agrees to render services as a personal manager to provide advice, guidance, counsel, and direction to Artist as Artist may reasonably require to further Artist's career as a [choose one: musician, composer, arranger, publisher, recording artist, producer, actor, writer and/or performing artist]. Manager's duties shall include but not be limited to the following services:

(a) To supervise and direct Artist's professional activities and, on Artist's behalf, to consult with others so as to assure the proper use and marketing of Artist's services; and

(b) To be available at reasonable times and places to confer with Artist in connection with all matters concerning Artist's professional career, interests, services and publicity; and

(c) To provide advice and counsel regarding the exploitation of Artist's personality in all media, as defined in paragraph one (1), and in connection therewith, to approve and permit, for the purpose of trade, advertising and publicity, the use, dissemination, reproduction and publication of Artist's name, photographic likeness, voice and artistic and musical materials; and

(d) To represent Artist in all dealings with any union; and

(e) To respond to any and all calls from Artist within 24 hours and be ready, willing and able to provide services to Artist immediately after returning said call.

2. Manager is not required to render Manager's exclusive services to Artist or to devote the entire time of Manager or the entire time of any of Manager's employees to Artist's affairs. Nothing herein shall be construed as limiting Manager's rights to represent other persons whose talents may be similar to or who may be in competition with Artist or to have and pursue business interests which may be similar to or may compete with those of Artist. Manager shall have the right to delegate management powers and responsibilities to others.

3. Likewise, Artist is not required to render Artist's exclusive services to and/or through Manager. Artist hereby appoints Manager as Artist's personal manager throughout the United States to render the services set forth in this agreement and in all matters usually and normally within the jurisdiction and authority of personal managers. Artist may engage any other agent, representative or manager to render similar services, and Manager agrees to accept a pro-rata share of any income otherwise due Manager hereunder. For the purpose of clarity, if Manager's fee is 15% of Artist's net income, and Artist has retained
